

HDSB eLearning Graduation Requirement Opt Out Form

Information



About the eLearning graduation requirement:

Students are required to earn two eLearning credits to graduate from secondary school **as part of the 30 credits required for the Ontario Secondary School Diploma (OSSD)**. This is beginning with every student who entered Grade 9 in the 2020-21 school year. The graduation requirement is intended to support students in developing familiarity and comfort with working and learning in a fully online environment, as well as developing digital literacy and other important transferable skills that will help prepare them for success after graduation and in all aspects of their lives.

eLearning credits are defined as courses that are delivered primarily asynchronously with learning between students and educators done through Brightspace, where coursework is teacher-led.

Parents/guardians may choose to opt their student out of the mandatory eLearning courses required for graduation. Students aged 18 years of age or older, or students who are 16 or 17 years of age and have withdrawn from parental control, can also opt out of the graduation requirement. School boards must also allow for students and parents/guardians to opt back into the eLearning graduation requirement should their decision change.

I understand the following statements:

- Upon receipt of the completed opt out form by my student's school/my school, my student/I will not be required to complete two eLearning credits to earn an Ontario Secondary School Diploma (OSSD) although this does not prevent them/you from taking an eLearning course in the future. An OSSD still requires 30 credits.
- My student/I will face no academic penalties for opting out of this graduation requirement.
- My student/I will continue to complete all other applicable graduation requirements.
- The request to opt out will be recorded on my student's/my subsequent provincial final report cards and transcript as "Online Learning Graduation Requirement - Non-Applicable".
- Should my decision change, my student/I can opt back into the eLearning graduation requirement by visiting my school's Guidance office.
