## **Background**

On October 19, 2016, the Board of Trustees will consider the motion from Report 16132 regarding initiating a Program and Accommodation Review process (PAR) for all secondary schools in Burlington.

As part of this process, there is a formal program and accommodation review consultation plan. This plan outlines the consultation process the Board is required to follow (as outlined in the Ministry of Education Pupil Accommodation Review Guideline, *Appendix A, Report 16132*). The Halton District School Board will adhere to this process.

The intent of this process is to create a committee (PARC), also prescribed by the Ministry of Education guideline, which will examine all relevant data pertaining to the accommodation review. The committee will also be the conduit for providing input from the community into both the process and any recommendations.

Following its deliberations, the committee will provide accommodation options and feedback to the Director of Education for consideration. The Director of Education will make a recommendation to the Board of Trustees. The final decision is made by the Board of Trustees. There will be no deviation from this process.

Due to the respect the Board has for its school communities, the students who attend these schools, and students who will attend in the future, there will be additional information sharing.

#### Purpose:

The purpose of this process is to provide the communities with the information and data that has prompted the initiation of the PAR process. The Ministry of Education outlines five (5) criteria, only one of which has to be met to initiate a PAR. (see Report 16132: Background)

Two of the criteria, and possibly a third, has been met for the secondary schools in Burlington. It is the Board's contention that Burlington secondary students may be impacted by the two criteria which prompted the PAR:

- The school or a group of schools has/have experienced or will experience declining enrolment where On-The-Ground Capacity (OTG) utilization rate is below 65%; and
- Reorganization involving the school or group of schools could enhance program delivery and earning opportunities.

The Board and the secondary schools in Burlington are facing a significant challenge in providing equity of opportunity for the current students of these schools, and for those who will attend in the future.

It is our intent to provide the communities with the information and data that has led to this perspective.
