## **Florence Meares PS - French Immersion Cohort Alignment Notification**

At the Nov. 3, 2021 Board meeting, HDSB Trustees approved a motion to initiate the process to review the Charles R. Beaudoin PS, Clarksdale PS, Rolling Meadows PS FI boundaries to eliminate the Grade 1 to Grade 2 FI split cohort at Florence Meares PS ([link to report](#)).

The Boundary Review Steering Committee included Trustee Andréa Grebenc, (Burlington Wards 3 and 6) Trustee Leah Reynolds (Burlington Wards 1 and 2), Superintendents of Education Aiman Flahat and Gord Truffen, and HDSB Planning Department Staff. The boundary review process is expected to be completed no later than Feb. 2022 with boundary changes to be implemented in Sept. 2022.

The proposed recommendations that will be presented to HDSB Trustees on Feb. 2, 2022, is as follows:

### **RECOMMENDATION:**

***BE IT RESOLVED THAT, the Halton District School Board adjust the boundaries for the Charles R. Beaudoin Public School French Immersion program as outlined in Option 1, as detailed in Report 22018, effective September 2022.***

***THAT, the Halton District Schools Board permit older siblings of students attending K to Grade 1 at Florence Meares PS, (as of September 2022) to be redirected from Clarksdale PS and/or Rolling Meadows PS, to Charles R. Beaudoin PS, with transportation for the September 2022 school year until graduation.***

It is proposed that students with older siblings currently in Grades 2-7 French Immersion will be able to elect to transfer over to Charles R. Beaudoin PS FI program with transportation beginning in Sept. 2022 with the intent of keeping the FI families together.
