boundaries for Milton SE #13 ps, and balance enrolments at established schools for both the English and French Immersion programs.

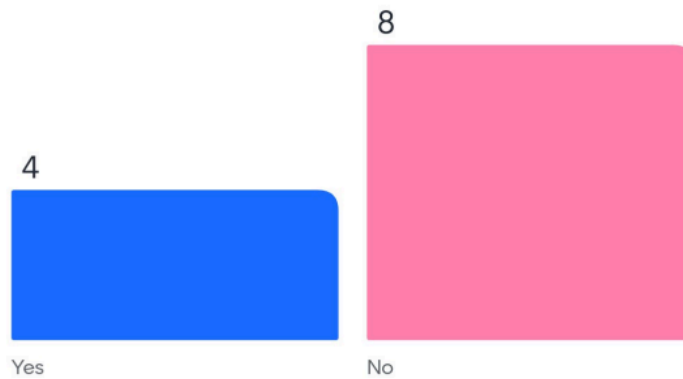

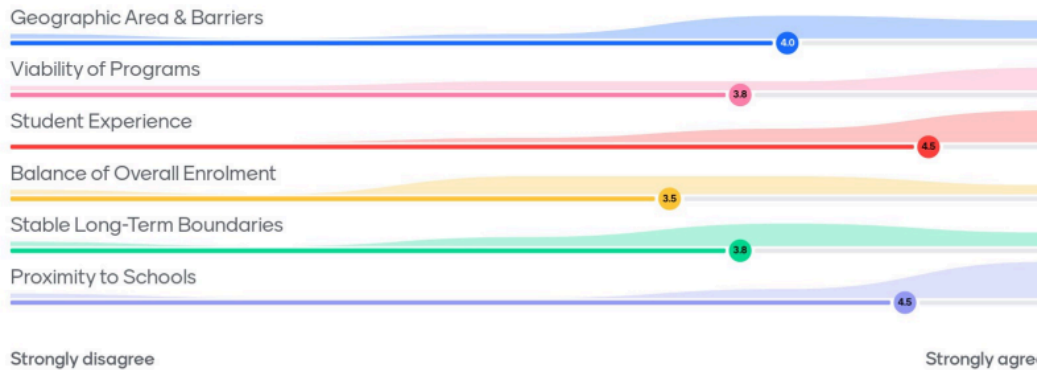


# Somewhere You Visited Over The Summer
