  - i) Public information meeting
    - (1) There was good attendance for the livestream.
      - (a) Around 40 concurrent viewers
  - ii) A good number of responses to feedback.
  - iii) The majority of responses were PL Robertson PS
  - iv) Good distribution of grades from responses.
  - v) Student experience and proximity to schools were the highest rated criteria from the public.

- vi) Option 6a is preferred from the public responses.
  - (1) However, due to the number of responses from PLR it has a better representation of that school than the other schools involved in the review.
- vii) The summary of themes from the feedback are presented and discussed.
  - (1) A point is made that the older FI sibling can follow the younger FI sibling to the new school to keep the children together.
- viii) A point is made to create a communication for registrations regarding the boundary review to avoid confusion and stress.

    - (2) There are few pockets for legacy exemption
    - (3) BRSC to provide details on siblings
