Burlington Secondary School Program and Accommodation Review (PAR)



Background

The Program and Accommodation Review (PAR) Committee has met four times in January and February to seek clarification of the Director's Preliminary Report, to review all options and to suggest new options.

Over these four meetings, the PAR Committee developed and reviewed more than 49 options, which have been narrowed down to the following six options.

A brief summary is provided below for each of the six options. Maps, rationale, issues,

enrolment projections and all program and boundary changes under each option are posted at each station.

OPTION 3c

- One school closure option. **Nelson HS** closes with program changes to **Burlington Central HS**, **Robert Bateman HS** and **Dr. Frank J. Hayden SS**.
 - The French Immersion (FI) program at Burlington Central HS is moved to Aldershot HS
 - The FI program at Dr. Frank J. Hayden SS is moved to M.M.Robinson HS
 - An FI program is added to Robert Bateman HS.
 - Secondary Gifted Placement is redirected from Nelson HS to Lester B. Pearson HS
 - Significant changes to all school boundaries
 - Remaining Burlington high schools will have
 213 available pupil places by 2020

OPTION 4b

- One school closure option.Robert Bateman HS closes.
 - Community Pathway Program (CPP) and Essential program are redirected to Nelson HS from Robert Bateman HS.
 For those programs, suitable facilities will be constructed at Nelson HS
 - International Baccalaureate (IB) program to be redirected from Robert Bateman HS to Lester B. Pearson HS
 - Secondary Gifted Placement to be redirected from Nelson HS to Lester B. Pearson HS
 - Significant changes to school boundaries north of the QEW
 - Remaining Burlington high schools will have 231 available pupil places by 2020

OPTION 7b

- No school closures. There are no program changes for any school.
 - Boundary changes to Dr. Frank J. Hayden SS (compressed), Lester B. Pearson HS (English expansion) and M.M. Robinson HS (FI and English expansion)
 - Boundaries south of the QEW do not change
 - Burlington high schools will have 1554 available pupil places by 2020

OPTION 19b

- Two schools closure option. Burlington Central HS and Lester B. Pearson HS close, with program changes to **Dr. Frank J. Hayden SS** and **Robert Bateman HS**.
 - English as a Second Language (ESL) program to be redirected to Aldershot HS from
 - Empty pupil places are available at Aldershot Elementary PS, which can be transferred to Aldershot HS without affecting elementary programming
 - The FI program to be removed from Dr. Frank J. Hayden SS. An FI program to be added to Robert Bateman HS. Students will be directed to Robert Bateman HS or M.M. Robinson HS
 - Significant boundary changes for all schools.
 - Remaining Burlington high schools will have 42 available pupil places by 2020

OPTION 23d

- Two school closure option. Robert Bateman HS and Lester B. Pearson HS close, with a program change to Dr. Frank J. Hayden SS
 - FI program at Dr. Frank J. Hayden SS is moved to M.M. Robinson HS
 - The IB program to be redirected from Robert Bateman HS to Burlington Central HS
 - Community Pathway Program (CPP) and Essential programming at Robert Bateman HS to be redirected to Nelson HS. Suitable facilities will be constructed at Nelson HS Remaining Burlington high schools will have a shortage of 411 pupil places by 2020

OPTION 28c

Two school closure option. Burlington Central HS and Lester B. Pearson HS close, with a program change to Dr. Frank J. Hayden SS

- English as a Second Language (ESL) program to be redirected to Aldershot HS from **Burlington Central HS**
- Empty pupil places are available at Aldershot Elementary PS, which can be transferred to Aldershot HS without affecting elementary programming
- The FI program at Dr. Frank J. Hayden SS is moved to M.M. Robinson HS
- Significant boundary changes for all schools
- Remaining Burlington high schools will have 42 available pupil places by 2020

- The survey can only be completed on a desktop or laptop computer. It cannot be accessed on a tablet or mobile device.
- The order in which the options appear in the survey is random.

The Board has sent an email to parents/guardians of all current elementary and secondary students in Burlington with a link to the survey.

Next Steps

Once all the feedback is collected, Ipsos will analyse the responses and provide the PAR Committee with a report of community feedback before the PAR Committee working meeting on March 23, 2017.

The PAR Committee will have an opportunity to review the Ipsos report and provide feedback to the Director. The Director will then make a recommendation to the Board of Trustees, who will ultimately make the final decision.
