



## Purpose: To centralize schools in their communities.

#### Note

### Anne J. MacArthur PS:

- No change to the English catchment. The FI catchment will include Anne J. MacArthur PS, P.L. Robertson PS and Boyne PS (north of Louis St. Laurent Blvd). Current FI students will remain at Anne J. MacArthur PS.
- Anne J, MacArthur PS enrolments are projected stabilize near 115% of OTG capacity.
- 6 to 13 portables are projected to be required for the next ten years.

#### Boyne P

- Boyne PS catchment north of Louis St. Laurent Blvd, includes all current catchment with the exception of the area west of the CNR tracks and south of P. L. Robertson PS catchment. The area bounded by Louis St. Laurent Blvd, CNR tracks, Whitlock Avenue, and Sixteen Mile Creek to remain at Boyne PS.
- Boyne PS enrolments are projected to increase near 125% of the OTG capacity.
- FI to attend Anne J. MacArthur PS (north of Louis St. Laurent Blvd) and Milton #10 SW ps (south of Louis St. Laurent Blvd).
- 3 to 9 portables are projected to be required from 2019 to 2027.

## P.L. Robertson PS

- The English boundary to be expanded south to Louis St. Laurent Blvd.
- P.L. Robertson PS enrolments are projected to exceed total capacity from 2018 & 2019. Projections will decline to 115% by 2026.
- The FI program grades 2-6 to be redirected to Anne J. MacArthur PS and grades 7 & 8 to be phased out, September 2018.
- The school will require 5 to 13 portable for the next ten years.

#### **Tiger Jeet Singh PS**

- The boundary south of Louis St. Laurent Blvd. will be directed to Milton #10 SW ps. Currently there are no students that reside in this area. No change to the current projections.
- The school will require 3 to 10 portables for the next ten years.

## Milton #10 SW ps

- English boundary to include the areas bounded by Louis St. Laurent Blvd, Whitlock Avenue, Tremaine Road, Britannia Road, Thompson Road and Sixteen Mile Creek. The FI boundary to include Boyne PS (south of Louis St. Laurent Blvd) and Milton #10 SW ps English catchments.
- Milton #10 SW ps is projected to open at 60% of OTG capacity. Total capacity is projected to be exceeded by 2021.
- FI to be phased in starting with grade 2, September 2018. One grade added per subsequent year. FI will likely become the preferred program.
